"on 10 October 1823 Ezekial Field filed a bill in chancery in the Jefferson County Circuit Court on behalf of himself, his sister Polly Brown (Mrs. George Brown), and the surviving children of thier brothers Cain and John, both dead, as hiers of the deceases Abraham Field. This bill disclosed they felt William Lewis and his wife Cynthia were getting an undue share of Abraham Field's estate and also missrepresenting the extent of Abraham's property and the agreement on which Abraham and Betty has lived on Lewis's land during the last 8 years of Abraham's life."
